

## Srinakharinwirot University Regulations Bachelor's Degree B.E. 2559 (2016)

## Section 5

## Educational Measurement and Evaluation

Item 23: Students must attend at least 80 percent of the total class time in order to be eligible to take the examination of the course, except for the course using self-study as a learning activity. The lecturer responsible for the course must inform students about the evaluation before studying.

Item 24: Educational evaluation

(1) The evaluation of the study results is as follows.

In the case that the courses in the curriculum are not evaluated by grade, the following symbols are used.

Symbol	Meaning
S	Academic performance / practice / internship / satisfactory
U	Academic performance / practice / internship / unsatisfactory

I	Incomplete
W	Withdrawn
IP	In progress

(3) The E grade is given according to the conditions besides the condition in (1).

(3.1) Student fail the exam.

(3.2) Students are absent from the examination without justifiable reasons.

(3.3) Students do not have enough time to study according to the criteria in Item 23.

(3.4) Students violate the examination regulations or commit examination fraud.

(3.5) An E grade will be given in place of an "I" grade if students does not comply with any criteria in (6).

(4) The S grade or U grade can be given only for the courses with no credits or the courses with credits, but the faculty committee agrees that it is not appropriate to evaluate the results of the study with grade. Or, it is the evaluation of the internship that grade is not defined. In the case that the students are given U grade, they must perform additional tasks until they are approved to pass the course.

(5) The I grade is assigned to students in the following cases.

(5.1) Students attend the class according to the condition mentioned in Item 23, but they do not take the exam because of illness or force majeure which is approved by the Dean.

(5.2) Students do not complete the course assignments. The lecturer, the head of the department or the chairman of the program administration committee agree to wait for the results of the study.

(6) To change the I grade, students are required to complete it within 4 weeks after the next semester starts. If not, the I grade will be changed to E grade.

(7) Students given grades from D and above are considered passing the course, except for the courses with other grading forms.

(8) The W grade is given in the following cases.

(8.1) Students are approved to withdraw the course in accordance with Item

22.

(8.2) Students are approved to take leave according to Item 30.

(9.3) Students drop out in that semester.

(8.4) Students are approved by the Dean to change from the I grade because illness or force majeure has not ended.

(9) The AU grade is given in the case that students are approved to enroll in the course with special reasons without credits according to Item 21.

(10) The IP grade is used for the practical courses organizing operations or projects for more than 1 consecutive academic year. The IP grade will be changed when the operations or projects in that course end. The evaluation of education is the grade level or S or U. However, the duration must not exceed 2 consecutive semesters.

(11) The study results must be verified by the program administration committee or the faculty committee and approved by the head of the department and the dean of the faculty before submitting to the Educational Service Division.

(12) The lecturers have to submit the study results within 2 weeks after the last day of the final exam for the first and second semesters and within 1 week for the summer semester.

If the lecturers do not submit the study results according to the schedule, it must be proceeded according to the announcement of the university

(13) The study results and the grade point average of the students transferred from other higher education institutions upon graduation, it must be proceeded as follows:

(13.1) The study results of the students transferred from other higher education institutions are separated and the name of the higher education institution is identified.

(13.2) Only the grade point average of the courses in the curriculum of Srinakharinwirot University is calculated.

Item 25 Repeating the course

(1) If students get E grade in any compulsory course, they have to retake the course or choose another course with comparable content. In case of choosing another course with comparable content, it must be approved by the head of the department or the chairman of the program administration committee offering that course and the dean of the faculty offering that course.

If study get E grade in non-compulsory course, they do not have to retake the course.

(2) In the case that the student has changed the faculty, the major or the minor and they get E grade in the compulsory course of the former major or minor, but it is not a compulsory course in the new major or minor, students do not have to repeat the course.

Item 26: Credits and calculation of grade point average

(1) The grade point average is calculated by counting the credits of the courses evaluated with A, B +, B, C +, C, D +, D and E.

(2) For the calculation of the grade point average in order to comply with the number specified in the curriculum, only D grade and over are counted.

(3) The grade point average for each semester is calculated from the study results in that semester. The sum of the multiples between the number of credits and the grades of courses is divided by the total number of credits in that semester.

(4) The grade point average is calculated from the study results of students from the beginning of studying until the last semester that students enroll. The sum of the multiples between the number of credits and the grade of each course is divided by the total number of credits.

(5) Calculation of the grade point average starts at the end of the second semester.

(6) In the semester that students get IP grade, it is not used to calculate for the grade point average for that semester, but it will be calculated in the semester that the course is evaluated with grade.

Item 28: Violation of the examination regulations or committing examination fraud

Students who violate the examination regulations or commit examination fraud may be punished as follows.

- (1) Fail in the course, or
- (2) fail in that course and to terminate from the study in the next regular semester or wait for the approval of degree of not more than 2 academic years, or
- (3) fail in all courses enrolled in that semester, or

(4) fail in all courses enrolled in that semester or drop out in the next semester or wait for the approval of degree of not more than 2 academic years, or

(5) terminate of student status

The consideration of such frauds shall be in accordance with the University announcement on examination fraud and any fraud related to education.
